

COMMERCIAL

MKA HOUSE, KING ST, MAIDENHEAD

Town centre office building with shops on the ground floor and flats at the rear.



LADYGROVE CENTRE, DIDCOT

Constructed in 2000, this district centre provides an Alldays convenience store, four other shops, a pub and a children's nursery, in the middle of a recent housing development.



GEORGIAN HOUSE, NEWBURY

Originally a Georgian property extended and converted in 1990, this property has four floors of offices finished to a high specification. Each floor is separately let.



120 HIGH STREET, HUNGERFORD

A period two-storey property at front comprising two shops with offices above with a modern development of 4 shops with flats above to the rear. Situated in the heart of Hungerford, the shops are spread along the footpath between the High Street and the railway station.



RICHFIELD PLACE, READING

A modern development of business units near the Town Centre in Reading. Deal Varney act for the management company who are responsible for all the common areas.



DUNSTON PARK, THATCHAM

Developed to serve its adjacent modern housing, this is a district centre with a large convenience store and four small units, together with a pub and a community centre.



7/9 THE BROADWAY, NEWBURY

Two floors of modern offices above a large retail unit at the north end of the main shopping street.



WEST MILLS YARD

An attractive courtyard development of small office units situated alongside the canal just off the Town Centre.



STUDLAND ESTATE, BALL HILL

A rural development of 10 industrial units around a courtyard in a village location outside Newbury



CASTLE INDUSTRIAL PARK NEWBURY

A development of 9 modern industrial units situated at the north-eastern side of Newbury Town Centre.



RESIDENTIAL

SELBORNE COURT, 98 KING'S ROAD, READING

Town centre 1980's flat complex of 25 high quality residential units. Arranged in 4 blocks ranging from 3 to 5 storey on the banks of the Kennet and Avon Canal. There is an underground secure car park and 2 lifts serving the units. Deal Varney have managed this block since 1997.



EKLO PLACE, GREENHAM ROAD, NEWBURY

An early 1980's estate of 67 flats arranged on two floors in blocks of 4, located on the edge of Newbury Town Centre.



MAIDEN PLACE, READING

A development of 152 flats by J. A. Pye alongside a district shopping centre. The flats are two-storey arranged around two central parking areas in blocks of 4, and they comprise a range of studio and galleried apartments. The flats are managed in conjunction with the nearby shopping centre as the costs of the car park and open spaces are shared.



CASTLE HOUSE, BATH ROAD, SPEEN

This property is a Grade II listed building constructed in about 1820 and converted and refurbished into 12 flats in 1990. Due to the age of this building there is a rolling programme of maintenance work.



BRANAGH COURT, OXFORD ROAD, READING

A new scheme built by Bloor Homes in 2005 comprising 125 flats with secure parking and lifts to all blocks. Services were set up from scratch to deal with all communal areas.



SHERIDAN COURT, LONDON ROAD NEWBURY

A development of 30 flats with landscaping, arranged in 2 blocks on arterial route in Newbury.



**JOSEPHINE COURT, SOUTCOTE ROAD
READING**

A development of 38 flats built in the 1970's arranged on three floors. Deal Varney are currently overseeing a major improvement programme to update the development.



TALISMAN HOUSE

A period building in the centre of Reading recently converted into 12 flats on 4 floors.



VICTORIA GARDENS, NEWBURY

Constructed in the late 1980's, the development consists of 42 flats with private parking situated in a tranquil location on the edge of Victoria Park in Newbury.



RIVERSIDE COURT, NEWBURY

Two, three storey blocks set in grounds. Deal Varney started managing them in 2008 and have overseen a programme of repairs and improvements since then.



FORBURY VIEW

A period building converted into apartments recently, right in the heart of Reading town centre.
